Fundraising

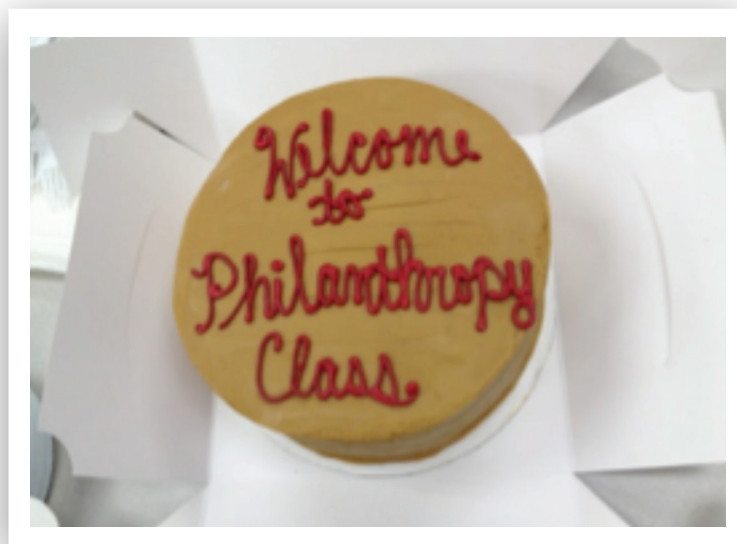
- Understand the philosophy of partnership selling, qualities of an effective salesperson, and elements of an effective sales cycle

- The students host an event at the end of the term to award their grants and thank their donors
